Roles and Responsibilities: Under the guidance of Head, | Head, Research and Development Cell, Head, Academic Affairs and over all supervision of the Director and the (i) Registrar, the incumbent shall perform following roles and responsibilities;

- (iii) Develop, plan, execute, monitor and report interdisciplinary (iii) Ability to research in collaboration with external Universities, Institutions, Government departments, industrial and Economic agencies, Judiciary within India and abroad;
- (iv) Provide input to general teaching faculty on latest research (iv) Fluency in English language. developments and emerging research trends in respective fields;
- (v) Participate in overall planning and development of academic, research, training and extension programs and activities of (i) the University in the area of Law and Sociology;
- (vi) Conduct research based training and extension activities in (ii) the area of Law and Sociology;
- (vii) Perform any other duties including administrative, coordination, etc. as required to achieve the aims and (iii) Excellent inter-personal and team-building objectives of the University.

- Master's Degree in Sociology or relevant subject with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) from a recognised Indian University, or an equivalent degree from an accredited Foreign University;
